MPI Membership Terms and Definitions

MEMBERSHIP TERMS

- **New Member**: A "new member" refers to anyone who is joining MPI for the first time **or** anyone who is **re**joining MPI after their membership was cancelled. All new members pay a \$50 application fee.
- **Join Date**: The date a membership is activated; the day a membership begins.
- Expiration or "Paid Thru" Date: The date through which a membership is paid. Membership dues for the following year are due by this date.
- Current Due: A "current due" member is a member whose expiration date falls in the current month.
 - o E.g., Jane Smith's membership expires May 13, so she is a current due member in the month of May.
- **Expired**: A membership that is past expiration date.
- **Renewal**: When a member pays their dues for the following membership year and there is not a lapse in tenure. Typically, renewals take place before membership is cancelled. However, renewals may also happen after the cancellation date if a member chooses to reinstate their membership.
- **Reinstate**: A type of renewal during which a member pays their dues after the cancellation date but does not lose tenure. If membership is reinstated, the annual expiration date does not change.
 - E.g., Jane Smith's membership expired May 13, 2024, and was cancelled August 1, 2024. She pays her dues on August 15, 2024, which reinstates her membership. Though she paid on August 15, 2024, her membership is extended from the original expiration date of May 13, 2024. She is now paid through May 12, 2025.
- **Grace Period**: The time following the expiration date before a membership is cancelled. This period includes any days in the current due month that follow the expiration date plus the next two months.
 - o E.g., Jane Smith's membership expires May 13, so her membership is in the grace period from May 14 through the end of July.
 - o Though they are expired, members in the grace period are still considered "active" members. During the grace period, members can renew in the membership portal on MPI.org and they continue to have access to all membership benefits in the portal.
- Active: A membership that has not been cancelled. Active members include those who are in their grace period. Active members are included in the Chapter Membership Roster, though some may be past their "Paid Thru" date.
- Cancelled or Terminated: A membership is cancelled if dues have not been paid by the end of the grace period. Cancellation happens on the first day of the third month following their expiration date. When a member is cancelled, they are no longer active, and they lose access to all member benefits.
 - o E.g., Jane Smith's membership expired May 13. She does not pay her dues during the grace period, so her membership is cancelled on August 1.

- **Tenure**: The total <u>uninterrupted</u> amount of time that a membership has been active. Tenure is maintained if membership is renewed or reinstated.
- **Rejoin**: When a member pays their dues *after cancellation* without maintaining tenure. They are considered "new members" and must pay the \$50 application fee to rejoin.
 - E.g., Jane Smith's membership expired May 13, 2024, and was cancelled August 1, 2024. She *rejoins* when she pays her dues on December 20, 2024. She is now paid through December 19, 2025.
- Former Member: A cancelled member; someone who previously had a membership but did not renew, reinstate, or rejoin.
- Membership Cycle: All the stages between a member's join date and their cancellation.
- Win Back Period: The months following a membership's cancellation during which efforts are made to "win" them back (i.e., get them to rejoin).
- **Renewal Excluded**: A member marked as "renewal excluded" has indicated they will not renew and should not be contacted about renewal until *after* the "Renewal Exclude Until" date.
